**A RESOLUTION OF THE CUPERTINO CITY COUNCIL
ADOPTING THE CUPERTINO
PARKS AND RECREATION SYSTEM MASTER PLAN**

WHEREAS, the Cupertino Parks and Recreation System Master Plan project (the "Project") identifies opportunities for park improvements and development, provides guidance for long-term decision making, and is intended to ensure that the City's parks and recreation system meets the needs of the Cupertino community and to guide the City in allocating resources for future development, renovation and management of City park and recreation facilities through the year 2040 ; and

WHEREAS, input from the community has been solicited over the course of several years regarding the Project; and

WHEREAS, from this input, the vision, mission and goals of the Project were identified; and

WHEREAS, the Cupertino Parks and Recreation Commission has served as an important forum for reviewing elements of the Project as its preparation has continued and has served a key role as an ongoing forum for community input; and

WHEREAS, in January 2019, the City issued an initial draft Master Plan and invited community input during ensuing months; and

WHEREAS, in October 2019, the City issued a revised draft Master Plan which incorporated revisions in response to the input received; and

WHEREAS, the community has had the opportunity to comment upon the revised draft Master Plan and such comments have been considered; and

WHEREAS, on February 18, 2020, the City Council adopted a Mitigated Negative Declaration for the Project and an associated Mitigation Monitoring and Reporting Program completed in accordance with the California Environmental Quality Act of 1970 (Public Resources Code Section 21000 *et seq.*) ("CEQA") together with the State CEQA Guidelines (California Code of Regulations, Title 14, Section 15000 *et seq.*) (hereinafter, "CEQA Guidelines"), and directed the filing of a notice of determination with the County Clerk of Santa Clara County; and

WHEREAS, the Cupertino Parks and Recreation Commission recommends City Council adoption of the Project; and

WHEREAS, the Project integrates the vision and aspirations of the community into a cohesive Master Plan to guide the development, renovation, and management of the City’s parks and recreation facilities in years to come.

NOW, THEREFORE, BE IT RESOLVED by the City Council that:

1. The draft Master Plan shall be finalized as a document dated February 2020, and any references within to its status as a “draft” document shall be removed.
2. The City Council hereby adopts the finalized February 2020 Cupertino Parks and Recreation System Master Plan.
3. This Resolution is effective upon its adoption.
